

- + A humidity-controlled environment is only successful if it stays in spec.




- + Too often humidity-controlled environments are out of spec, and the problem is either unseen or unknown.

Softening of Packaging

Corrosion is a **24/7/365 Battle**

- + Mold, mildew, insects at 70% RH
- + Softening of packaging at 55% RH
- + Corrosion at 50% RH
- + Contact corrosion on electronics at 40% RH

Maintaining less than 40% RH prevents all of the above.

CFE Assurance Sources of **Failures**

- Doors left open too long due to lack
 of awareness regarding how long is
 too long.
- + Equipment turned off by personnel (typically due to lack of awareness regarding its purpose).
- + Equipment failure (usually the result of a lack of maintenance).

- + Incorrect or insufficient equipment (e.g. a condensing unit dehumidifier in a cold climate).
- + Facility shortcomings.
- + The inability to determine when a facility is out of spec "by feel".

- + An environment that allows you to control humidity levels. (We can retro-fit existing space or put up purpose-built space.)
- + Humidity control systems that work in any climate (this excludes condensing units) and are standardized for the purpose of part-sourcing, maintenance, training, etc.

- + Eyes-on inspections and regular maintenance.






